<u>Single Family New Construction</u> - Residential flat rate fee for new dwelling Includes base fee and a maximum of 3 inspections (Fee rev. 3/23)	185
All other structures use fee schedule below:	
Manufactured or mobile homes: <i>includes 1 inspection</i> (Fee rev. 3/23)	90
Manufactured or mobile homes w/ basement: <i>includes 2 inspections</i> (Fee rev. 3/23)	130
